

General Sales Terms – Smart2Move European Summit 2025

Article 1 – Offer of Services

Article 2 – Prices and Methods of Payment

All prices listed on our website or sent by email are current at the time of communication and may be updated without prior notice.

Accepted currency:

- **Euros (EUR)** for the European Community and international attendees

Accepted payment methods:

- Credit Card (via our secure Stripe platform)
- Bank Transfer (must be completed and received at least 7 days before the event)

By submitting payment, you accept these terms in full. If you do not agree, please notify us immediately to cancel your registration within the applicable cancellation period.

Article 3 – Billing Method

Participants are responsible for full payment of the registration fee as indicated on the website or invoice.

- Credit card payments must be completed at the time of online registration
- Bank transfer payments must be completed **no later than 7 days before the event start date** to confirm your seat
- All invoices are due immediately upon receipt, unless otherwise stated

Special promotions or early bird pricing are only valid during the periods specified on our website or promotional materials.

Article 4 – Communication & Documentation

All contractual and event-related communication will be conducted via email. It is the participant's responsibility to provide a valid and monitored email address and ensure proper receipt of all event communications.

Participation Certificate:

Each attendee will receive a **Smart2Move European Summit Certificate of Attendance** following the event. This document confirms your participation but does not constitute a certification or qualification.

Article 5 – Cancellation Policy

Participant Cancellation:

- Cancellation made more than **45 days before the event: 100% refund**
- Cancellation made within **45 days of the event: registration is non-refundable**

Event Cancellation (by Smart2Move):

- In the event of cancellation due to force majeure (e.g., natural disaster, political unrest), Smart2Move is not liable for participant-incurred costs
- If Smart2Move cancels the event for any reason, participants may choose between a **full refund** or **credit toward a future event**
